**NOTIFICATION**

Bhubaneswar, dated the 15.5.2014

No.HOME-DA1-MISC-0140-2013/ 18558 / D&A. In exercise of the

powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of previous notification relating to Astaranga Police Station on the subject, the State Government do hereby declare establishment of a Marine Police Station at Nuagarh in Sadar Sub-Division of Puri District to be called as **Astaranga Marine Police Station** under Coastal Security Scheme, Phase - II of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between Nuagarh under Astaranga Police Station and Chhotipada under Kakatpur Police Station with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlet which were hitherto included in Astaranga Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.
